(Approving the Executive Branch Administrative Plan)**

3 **WHEREAS, the Constitution of the Tohono O'Odham Nation, Article**  
4 **VII, Section 2(a) mandates the Chairman of the Tohono**  
5 **O'Odham Nation to develop an Administrative Plan,**  
6 **hereafter known as the Plan, to be approved by the**  
7 **Tohono O'Odham Legislative Council; and**

8  
9 **WHEREAS, an Administrative Plan Development Team, APDT, was**  
10 **organized and chaired by the Chairman of the Tohono**  
11 **O'Odham Nation to direct the development of the Plan;**  
12 **and**

13  
14 **WHEREAS, the APDT involved Executive Branch employees in a**  
15 **process to develop the Plan by engaging in a thorough**  
16 **assessment of tribal program strengths, weaknesses,**  
17 **barriers, resources and strategies; and**

19 **WHEREAS, the Chairman of the Tohono O'Odham Nation did**  
20 **present the Plan to the eleven districts of the Nation for**  
21 **input and has since brought the Plan before the Council**  
22 **on numerous occasions; and**

24 **WHEREAS, the state of the Nation is such that it is critical that the**  
25 **Executive Branch proceed with its proposed initiatives**  
26 **to improve the service delivery to members of this**  
27 **Nation, its programs and districts.**

Legislative Council that it hereby approves the Executive

which a quorum was present with a vote of 939.0 FOR; 644.0  
AGAINST; -0- NOT VOTING; and 180.0 [08] ABSENT, pursuant to the  
powers vested in the Council by Section 2(a) of Article VII of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
