11 **occasions, the opportunity to inquire into the fitness of**
12 **this candidate for the Office of Director of Human**

15 **WHEREAS, after conducting such inquiry, the Tohono O'Odham**
16 **Legislative Council finds that Ms. Lahti is qualified to**
17 **hold the position of Director of the Tohono O'Odham**
18 **Human Resource Department.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
21 **Legislative Council that Chairman Listo's appointee,**
22 **Martha Lahti, is hereby confirmed as Director of the**
23 **Tohono O'Odham Human Resource Department.**

26 **The foregoing Resolution was presented to the Tohono O'odham**
27 **Legislative Council on the 11TH. day of JULY, 1994 at a meeting at**
28 **which a quorum was present, and by a vote of 457.0 FOR; 1,306.0**
AGAINST; -0- NOT VOTING; AND 07 ABSENT, failed to pass because it
did not receive a majority of the votes cast as required by Section 2
of Article V of the Constitution of the Tohono O'Odham Nation.


