3 **WHEREAS, the Tohono O'odham Nation is submitting an application**
4 **for a grant to fund the following home renovation**
5 **projects: Comobabi, Pisinemo, under the Indian**
6 **Community Development Block Grant Program and in**
7 **connection with the approved grant, resolves and makes**
8 **certain assurances; and**

10 **WHEREAS, prior to the submission of this amendment request, the**
11 **Tohono O'odham Nation has provided tribal citizens,**
12 **especially those living in areas where activities are**
13 **proposed or ongoing, with adequate information**
14 **concerning the amount of funds available for proposed**
15 **community development and housing activities, the**
16 **range of activities that may be assisted, and other**
17 **important program requirements, and solicited their**
18 **views and participation; and**

21 **WHEREAS, the traditional Tribal means of citizen involvement were**
22 **followed through District Council meetings and Tohono**
23 **O'odham Legislative Council meetings, and opportunity**
24 **was given to articulate needs, express preferences about**
25 **proposed community development and housing**
26 **activities, assist in the selection of district priorities, and**
27 **otherwise participate in the development of the**

3 **WHEREAS, comments or views expressed by Tribal members were**
4 **considered and modified the application accordingly;**

6 **WHEREAS, the modified application has been made available to**
7 **Tribal members for review and comment.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**
10 **Legislative Council hereby certifies that the Tohono**
11 **O'odham Nation provided its citizens with the**
12 **opportunity to participate in the development of the**
13 **proposed Community Development Block Grant request.**

14 **BE IT FURTHER RESOLVED that no part of this paragraph shall be**
15 **constructed to restrict the responsibility and authority**
16 **of the applicant for development of the application and**
17 **the execution of its Community Development Block**
18 **Grant program. Accordingly, the citizen participation**
19 **requirements of this paragraph do not include**
20 **concurrence by any person or group involved in citizen**
21 **participation in making final determinations concerning**
22 **the findings and contents of this amendment. The sole**
23 **responsibility and authority to make such final**
24 **determinations rest exclusively with the Tohono**
25 **O'odham Legislative Council.**


