approval by the Tohono O'odham Legislative Council;
and**

**WHEREAS, an amendment has been submitted to reflect the
following amounts for review and approval by the
JTPA/DES/Title IIC Program.**

ACP - \$13,460

PROGRAM - \$71,789

**NOW THEREFORE, BE IT RESOLVED that the Tohono O'odham
Legislative Council does hereby approve the amendment
to the JTPA Title IIC ACP/Program and authorizes
expenditures in accordance with the attached budget.**


**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative


funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 19TH. day of JULY, 1994 at a meeting at which a quorum was present with a vote of 1,639.0 FOR; -0- AGAINST; -0- NOT VOTING; and 124.0 [10] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


