4 **JTPA/JOBS Title II Program funded by the Department of**
5 **Health and Human Services, Family Support**
6 **Administration (DHHS/FSA); and**

8 **WHEREAS, the Nation has been informed of its final allocation for**
9 **FY 1994 JOBS Program in the amount of \$150,868.; and**

10 **WHEREAS, any amendments affecting the funding or funding levels**
11 **of the grant shall be submitted for review and approval**
12 **by the Tohono O'Odham Legislative Council; and**

14 **WHEREAS, an amendment has been submitted for review and**
15 **approval by the JTPA/JOBS Title II Program.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
18 **Legislative Council that it does hereby approve the**
19 **amendment to the JTPA/JOBS Title II Program and**
20 **authorizes expenditures in accordance with the attached**
21 **budget.**

23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative**
24 **Council that the Tohono O'Odham Nation's Officials, to**
25 **wit: the Chairman and any designated official are**

O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
