**RESOLUTION NO. 94-309**

**WHEREAS, on June 9, 1994 by Resolution 94-233 the Tohono  
O'odham Legislative Council appointed Wayne Harris to  
the Election Board for a 5 year term and;**

**WHEREAS, on June 20, 1994 the Rules Committee of the Tohono  
O'odham Legislative Council met with the chairperson of  
the Election Board to discuss the terms of the remaining  
Board members. According to Article II, Section 1 (B) of  
the Uniform Election Ordinance.**

1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
