(Vacating Unconfirmed Appointment Position)**

**DEFEATED

3 **WHEREAS, on July 11, 1994 Chairman Sylvester Listo, pursuant to**  
4 **Article VII, Section 2(e) of the Tohono O'odham Nation's**  
5 **Constitution, recommended Martha Lahti for confirma-**  
6 **tion as Director of the Tohono O'odham Human**  
7 **Resources Department; and**

10 **WHEREAS, the Tohono O'odham Legislative Council by Resolution**  
11 **No. 94-255 did not confirm the appointment of Martha**  
12 **Lahti as Director of the Tohono O'odham Human Re-**  
13 **sources Department.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**  
16 **Legislative Council that Martha Lahti was not confirmed**  
17 **by the Tohono O'odham Legislative Council and that this**  
18 **position be vacated on August 11, 1994 pursuant to**  
19 **Resolution No. 94-255.**

21 **The foregoing Resolution was presented to the Tohono O'odham**  
22 **Council on the 3rd day of August, at a meeting at which a quorum**  
23 **was present, and by a vote of 248.0 FOR; 1,089.0 AGAINST; 248.0 NOT**  
24 **VOTING; AND 178.0 [06] ABSENT, failed to pass because it did not**  
25 **receive a majority of the votes cast as required by Section 2 of Article**  
26 **V of the Constitution of the Tohono O'Odham Nation.**


