15		Legislative Council and the Health and Human Services

20 21	WHEREAS,	the Tobacco Tax and Health Care Act initiative is an						
22		invidious attempt to increase the ability of the State of						
23		Arizona to impose state taxes upon the on-reservation

27	WHEREAS,	the Nation has previously opposed attempts by the State						
28		of Arizona to impose state taxes upon on-reservation

sales of tobacco (see, for example, Amicus Curiae Brief of the Tohono O'odham Nation filed June 3, 1991 in Arizona v. Dillon, Case No. 1-CA-TX-90-033); and

the Tobacco Tax and Health Care Act initiative is WHEREAS, incompatible with the Nation's stated opposition in Resolution No. 94-113 to the right of the state to levy taxes upon on-reservation activities; and

the Health and Human Services Committee recommends WHEREAS. that Resolution No. 94-113 be repealed and the Nation's support for the Tobacco Tax and Health Care Act initiative be withdrawn.

## **NOW, THEREFORE, BE IT RESOLVED THAT:**

- The Tohono O'odham Nation supports efforts to 1. reduce the use of tobacco products by its members as a method of reducing the tobacco related illnesses of its members.
- The Nation does not support such efforts which 2. diminish or intrude upon the Nation's right to make its own laws and to be ruled by them.
- Resolution No. 94-113 is hereby repealed. 3.
- The Nation expressly withdraws the consent given 4. in Resolution No. 94-113 to Arizona for a Healthy
