**WHEREAS, the Nursing Home Project in the Executive Branch of
the Tohono O'Odham Nation receives funding directly
from the Tohono O'Odham Nation; and**

**WHEREAS, the Program's current mode of operation (two meetings
per month) requires modification to the approved
budget (one meeting per month); and**

**WHEREAS, the Program budget requires modifications to include
line items not anticipated; and**

**WHEREAS, the Nursing Home Project has submitted a budget
modification for approval by the Legislative Council of
the Tohono O'Odham Nation, with a request for a
reallocation of funds within the existing budget of
\$166,353.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the
Tohono O'Odham Nation that it approves the FY
1993/1994 budget modification submitted by the
Nursing Home Project and reallocates funds within the
existing budget of \$166,353.**


