WHEREAS, the Chairman of the Nation and the Governor of the O'odham in Mexico did mutually sign and send a letter to the Mexican officials in charge of the Biosphere Reserve to indicate that the O'odham on both sides of the border planned to participate in the development and management of the Pinacate and Gran Desierto Biosphere Reserve; and

under Article XVI, Section 9 of the Constitution of the Tohono O'odham Nation it is mandated that the Nation attempt to restore the lands of historic Papagueria, and under Article XVIII, Sections 1 and 2 of the Constitution of the Tohono O'odham Nation it is mandated that the

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby approves a Consultant Contract with Kim H. Robinson, in the amount of \$23,000 and in the form attached hereto.
- 2. The Legislative Council appropriates the sum of \$23,000 from the General Revenue Account to pay the fees and expenses under the Consultant Contract

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the <u>5TH.</u> day of <u>AUGUST</u>, <u>1994</u> at a meeting at which a quorum was present with a vote of <u>1,218.0</u> FOR; <u>-0-AGAINST</u>; <u>269.0</u> NOT VOTING; and <u>276.0 [09]</u> ABSENT, pursuant to the powers vested in the Council by Section <u>1(d)(2) & (3)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
