

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Partial Waiver of Indirect Cost for the Head Start Program)**

3 **WHEREAS, the Tohono O'Odham Nation established a policy to**  
4 **require the inclusion of indirect costs in all third party**  
5 **funded agreements; and**

6 **WHEREAS, the policy provides for an exception and waiver of the**  
7 **requirement by the Legislative Council, if it is in the**  
8 **best interest of the Nation to do so, that is when the**  
9 **benefits to the Nation exceeds the need to collect the**  
10 **revenues from the funding agency; and**

13 **WHEREAS, funding from the Department of Health and Human**  
14 **Services for the FY 1994 Early Childhood Head Start**  
15 **Program is insufficient to cover both direct and**  
16 **indirect cost needs of the program; and**

17  
18 **WHEREAS, the Early Childhood Head Start Program is requesting**  
19 **that a partial waiver of the Indirect Cost in the amount**  
20 **of \$93,269., be waived.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham**  
23 **Legislative Council finds that it is in the best interest of**  
24 **the Nation to partially waive the indirect cost funding**  
25 **requirement for the FY 1994 Early Childhood Headstart**




