Early Childhood Head Start Program funded by the  
Department of Health and Human Services, Family  
Support Administration (DHHS/FSA); and**

**WHEREAS, the Nation has been informed of its Program  
Improvement and Salary Adjustment Funds for FY 1994  
Early Childhood Head Start Program in the amount of  
\$152,650.; and**

**WHEREAS, any amendments affecting the funding or funding levels  
of the grant shall be submitted for review and approval  
by the Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and  
approval by the Early Childhood Head Start Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham  
Legislative Council that it does hereby approve the  
amendment to the Early Childhood Head Start Program  
and authorizes expenditures in accordance with the  
attached budget.**

16 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
17 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
