**WHEREAS, the Tohono O'Odham Nation has consistently supported
the nurturance of its young members by providing their
welfare through various programs and services designed
to meet their special needs; and**

**WHEREAS, the Tohono O'Odham Rural Project for Disabled 3 to 5
years old was subcontracted to Indian Oasis Baboquivari
Unified School District #40 during Fiscal Year 1993; and**

**WHEREAS, the Tohono O'Odham Head Start Program does desire to
continue to subcontract with Indian Oasis Baboquivari
Unified School District #40 during Fiscal Year 1994 and
has the responsibility of overseeing and administering
the Intergovernmental Agreement; and**

**WHEREAS, the Terms and Conditions are set forth in the
Intergovernmental Agreement attached to the
Resolution; and**

**WHEREAS, the Tohono O'Odham Legislative Council has authority to
enter into agreements, such as this, pursuant to Article
VI Section 1(f) of the Tohono O'Odham Constitution.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the Intergovernmental Agreement, provided however, that any amendments affecting the funding or funding levels of the Intergovernmental Agreement shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 5TH day of AUGUST, 1994 at a meeting at which a quorum was present with a vote of 1,585.0 FOR; -0- AGAINST; -0- NOT VOTING; and 178.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
