5 **WHEREAS, the HICKIWAN District Council strongly oppose Tohono**
6 **O'Odham Legislative Council Resolution #94-305, based**
7 **on circulating information for equal distribution on**
8 **gaming revenues from Commerce Committee; and**

10 **WHEREAS, enrollment accuracy and residency became an issue at**
11 **one Casa Grande meeting on Gaming Revenues.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
14 **Legislative Council that it hereby rescinds Tohono**
15 **O'Odham Legislative Council Resolution #94-305, and**
16 **implements equal distribution immediately.**

26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
27 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
