

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appropriation of Funding to Purchase, Transport and Deliver  
Cattle Feed from the Vaiva Vo Farms)**

**RESOLUTION NO. 94-333**

**WHEREAS, the Tohono O'odham Nation Legislative Council did discuss prevailing drought conditions within the boundaries of the Nation on August 5, 1994 and the drought conditions were considered a major problem with negative consequences to the welfare of the Nation's cattle owners; and**

**WHEREAS, the Vaiva Vo Farms was identified as the source for securing feed for livestock of the Nation's cattle owners; and**

**WHEREAS, the Legislative Council did authorize the Executive Office to begin investigations on the procurement, transportation of, and delivery of feed to each district; and**

**WHEREAS, the Executive Office did investigate the availability of feed at the Vaiva Vo Farms and submitted costs associated with the procurement, transport requirements, and delivery of feed for the main portion of the Nation; and**

**WHEREAS, the expense for the procurement, transport requirements, and delivery of livestock feed for nine districts is estimated to be \$21,710.00 .**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham**

**BE IT FURTHER RESOLVED that the sum of \$50,000.00 for the procurement, transport of, and delivery of livestock feed for the nine districts of the main reservation, shall be taken from the Nation's General Revenue Account.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 08TH. day of AUGUST, 1994 at a meeting at which a quorum was present with a vote of 1,412.0 FOR; -0- AGAINST; 49.0 NOT VOTING; and 302.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


