RESOLUTION NO. 94-340

**WHEREAS, the Chukut Kuk District Council met on July 16, 1994 at
which time a quorum was present; and**

**WHEREAS, the Chukut Kuk District Council did approve budget
modification No. 10, creating the "Capital Equipment"
line item to purchase a copy machine in the amount of
\$3,555.; and**

**WHEREAS, there are sufficient monies to establish the "Capital
Equipment" line item for this purchase; and**

**WHEREAS, the copy machine (RL717Z, Serial No. J246560) presently
located at the District Office will be used as a trade-in
and is valued at \$1,900.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it hereby approves Chukut Kuk
District Council's budget modification no. 10 creating
the "Capital Equipment" line item to purchase a copy
machine in the amount of \$3,555.**

Legislative Council on the 11TH. day of AUGUST, 1994 at a meeting
at which a quorum was present with a vote of 1,526.0 FOR; -0-
AGAINST; -0- NOT VOTING; and 237.0 [10] ABSENT, pursuant to the
powers vested in the Council by Section 1(d)(3) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


