**WHEREAS, by Resolution No. 93-350 the Tohono O'Odham
Legislative Council appropriated funds to operate the
Baboquivari District/Fresnal Canyon Community for
Fiscal Year 1994; and**

**WHEREAS, any amendments affecting the funding level or change
in the purpose for which the funds were budgeted are
required to be submitted for review and approval by the
Tohono O'Odham Legislative Council; and**

**WHEREAS, Baboquivari District/Fresnal Canyon has submitted a
budget modification in the amount of \$375.00 to
transfer funds from existing line item #9210 - Repair
and Maintenance Other to line item #9310 - Equipment
Other to cover related expenses.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it hereby approves this
modification to create a new line item to the
Baboquivari District/Fresnal Canyon budget.**
