- WHEREAS, the Chairman of the Tohono O'Odham Nation made a written request on December 17, 1993 to Mr. Walt Mills, Area Director, BIA Phoenix Area Office, requesting a waiver on caliber of weapons used by the Nation's Police from a 9mm semi-automatic pistol to a .40 cal. semi-automatic pistol; and
- WHEREAS, on January 14, 1994, the Acting Area Director, BIA
