**WHEREAS, the Tohono O'odham Nation is cognizant of the need to
work cooperatively with all agencies located on our
Nation in order to improve the quality of life for our
O'odham; and**

**WHEREAS, Nina Innis, a member of the Tohono O'odham Nation
has demonstrated exemplary administrative skills and
knowledge as an employee within the Papago Agency -
Bureau of Indian Affairs, and currently as
Superintendent of the San Carlos Apache Agency; and**

**WHEREAS, the Tohono O'odham Nation supports tribal members
who are desirous of returning to their Nation to assist in
developing cooperative relationships and applying
enhanced managerial ability in order to plan, develop,
and evaluate the existing conditions of the Tohono
O'odham Nation.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it
hereby recommends to the Phoenix Area Office and to
the Department of the Interior - Bureau of Indian Affairs
of its support for Nina Innis as the Superintendent of the
Papago Agency - Bureau of Indian Affairs, located in
Sells, Arizona.**

BE IT FURTHER RESOLVED that the Nation's Chairman shall execute a formal letter and supporting resolution to all appropriate agencies and individuals.


The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH. day of SEPTEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 1(k) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
