RESOLUTION NO. 94-359

**WHEREAS, on August 8, 1994, the Legislative Council did approve
Resolution No. 94-333 entitled, "Appropriation of
Funding to Purchase, Transport and deliver Cattle Feed
from the Vaiva Vo Farms"; and**

**WHEREAS, the resolution and justification did not include the San
Xavier District; and**

**WHEREAS, the Nation's Chairman was approached by a rancher
residing in San Xavier District requesting a distribution
of hay, for which the Chairman authorized said request
of 134 bales of hay totalling \$804.00 dollars; and**

**WHEREAS, after receiving all invoices and Accounting print out of
the expenditures, the appropriation is less, \$4,122.96.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it
hereby amends Resolution No. 94-333 entitled,
"Appropriation of Funding to Purchase, Transport and
deliver Cattle Feed from the Vaiva Vo Farms" to include
the San Xavier District in the distribution of hay.**

**BE IT FURTHER RESOLVED by the Legislative Council that it hereby
appropriates an additional \$4,122.96 from the General
Revenue fund to cover the cost for the expenditures
from Vaiva Vo Farms.**






