RESOLUTION NO. 94-368

**WHEREAS, the districts of Baboquivari, Sells, Gu Achi and Chukut
Kuk by Resolution No. 94-01, Requesting immediate
Distribution from San Xavier District's Thirty (30%)
Allocation be distributed Equal as stated in Res. No. 94-
331; and**

**WHEREAS, Res. No. 94-331 rescinded Res. No. 94-305 and did not
rescind Res. No. 94-098 as stated in Res. No. 94-01 of the
Four Districts; and**

**WHEREAS, Res. No. 94-098 (Authorizing Gaming Revenue
Distribution Formula) 1B(ii) states that 30% of Gaming
Revenues be allocated to the District where the gaming
facility is located; and**

**WHEREAS, the gaming facility is located in the San Xavier District of
the Tohono O'odham Nation and Res. No. 94-098 is still
in place; and**

**WHEREAS, Res. No. 94-331 rescinds Tohono O'odham Legislative
Council Res. 94-305 and implements equal distribution
immediately.**

Legislative Council hereby reaffirms Res. No. 94-331 and**

14 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
15 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


