**WHEREAS, the Tohono O'odham Nation is presently operating the  
Employment Assistance Readiness Net (EARN) Program  
under FY'94 P.L. 93-638 contract with the Bureau of  
Indian Affairs; and**

**WHEREAS, such Tribal operations have been successful and  
beneficial to the Tohono O'odham Nation and its people;  
and**

**WHEREAS, the Nation intends to continue the operation of the EARN  
Program which in the future will be referred to as the  
Readiness Employment Assistance Program.**


**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation  
Legislative Council that it does authorize and request  
the Bureau of Indian Affairs to continue the operations  
and funding for the provision of services for the  
Readiness Employment Assistance Program for FY'95.**

**The foregoing Resolution was passed by the Tohono O'Odham  
Legislative Council on the 14TH. day of SEPTEMBER, 1994 at a  
meeting at which a quorum was present with a vote of 1,763.0 FOR;  
-0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the  
powers vested in the Council by Section 1(f) of Article VI of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


