

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Hickiwan District Budget - FY '95)**

RESOLUTION NO. 94-374

WHEREAS, the constitution of the Tohono O'Odham Nation, under Article IX District Council Organization, Section 7 outlines budget authorization; and

WHEREAS, the Hickiwan District Administration did draft the District Administration Budget FY '95 and presented the budget to the Hickiwan District Council, then taken to their respective communities for community input; and

WHEREAS, based on community input the administration redrafted the FY '95 budget, adding on the community concerns; and

WHEREAS, the final FY '95 budget was presented to the Legislative Council.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the Hickiwan District FY '95 Budget in the amount of \$265,098.20

BE IT FURTHER RESOLVED that the Hickiwan District has sufficient funds under its account to cover said budget.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 15TH. day of SEPTEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,646.0 FOR; -0- AGAINST; -0- NOT VOTING; and 117.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
