**WHEREAS, the Pisinemo District Council did meet on Wednesday,
September 14, 1994, at a regularly scheduled meeting;
and**

**WHEREAS, the Pisinemo District Council did approve to ask for
authorization to incur costs until a budget is in place;
and**

**WHEREAS, no final analysis of the Pisinemo District's budget was
prepared due to the District Representative's/Alternate's
request for additional time to meet with their villages to
discuss the FY-95 Budget; and**

**WHEREAS, the Pisinemo District is not prepared to present and
implement a FY-95 Budget.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council hereby approves the Pisinemo
District's request for authorization to incur costs until a
budget is in place.**

**BE IT FURTHER RESOLVED that the Pisinemo District Council will
prepare and present a base budget for FY-95 to the
Tohono O'Odham Legislative Council as soon as it is
prepared.**




