RESOLUTION NO. 94-379

**WHEREAS, the Tohono O'Odham Nation is presently operating the
Water Resources Study Program under the FY 1992 P. L.
93-638 contract with the Bureau of Indian Affairs; and**

**WHEREAS, the Nation has been informed by the Bureau of Indian
Affairs of two supplements to FY 1994 funding with
document dates of June 21, 1994 and September 1, 1994,
providing additional funds in the amounts of \$200,000.,
and \$190,000., respectively, for a total of \$390,000. These
funds are in addition to the FY 1994 entries providing
\$640,000., to the Papago Agency for the Tohono O'Odham
Nation water inventory investigations associated with
P. L. 97-293, the Southern Arizona Water Settlement Act;
and**

**WHEREAS, any amendments affecting the funding or funding levels
of the contract shall be submitted for review and
approval by the Tohono O'Odham Legislative Council;
and**

**WHEREAS, an amendment has been submitted for review and
approval by the Water Resources Study Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council does hereby approve the requested**
