

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1995 Low Income Home Energy Assistance Program Budget
Modification #1)**

RESOLUTION NO. 94-380

WHEREAS, the Tohono O'Odham Nation is presently operating the Low Income Home Energy Assistance Program under a grant with the State of Arizona, Department of Economic Security; and

WHEREAS, the Tohono O'Odham Nation has been informed to revise the Administrative Cost to reflect the allocation of \$3,125 and Program Cost of \$4,851 for FY 1995 in the amount of \$48,935; and

WHEREAS, Tohono O'odham Social Services has submitted a budget modification reflecting the Administrative Cost and Program Cost Allocation for review and approval; and

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the budget modification to the Low Income Home Energy Assistance Program and authorizes expenditures in accordance to the attached budget modification.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated Official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be

submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH day of SEPTEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




