RESOLUTION NO. 94-384

**WHEREAS, the Tohono O'Odham Nation is presently operating the
Community Health Services Program under FY 1993 P. L.
93-638 contract with the Indian Health Services; and**

**WHEREAS, the Nation has been informed of one time funding for
Health Promotion/Disease Prevention Activities of
\$15,000.; and**

**WHEREAS, a budget has been submitted for review and approval by
the Community Health Services Program for the Health
Promotion and Disease Prevention funds.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it does hereby approve and
requests Indian Health Services to modify the
Community Health Services Contract No. 249-94-0002 to
incorporate the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative
Council that the Tohono O'Odham Nation's Officials, to
wit: the Chairman and any designated official are hereby
authorized to negotiate and execute the contract,
provided, however that any amendments affecting the
funding or funding levels of this contract shall be
submitted for further prior approval by this Council.**


