**WHEREAS, the Tohono O'Odham Nation is presently operating the  
CHR Specialty Training Program under FY 1994 P.L. 93-  
638 contract with the Indian Health Services; and**

**WHEREAS, the Nation has been informed of its FY 1994 allocation in  
the amount of \$13,920.00; and**

**WHEREAS, any amendments affecting the funding or funding levels  
of the contract shall be submitted for review and  
approval by the Tohono O'Odham Legislative Council;  
and**

**WHEREAS, an amendment has been submitted for review and  
approval by the Community Health Services Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham  
Legislative Council that it does hereby approve the  
amendment to the CHR Specialty Training Program  
contract and authorizes expenditures in accordance with  
the attached budget.**


**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 15TH day of SEPTEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 07 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
