O'odham Nation's Constitution, Chairman Sylveester
Listo's Administrative Plan was approved by the
Legislative Council pursuant to Resolution No. 94-253
entitled, "Approving the Executive Branch Administrative
Plan" which includes the consolidation of Health and
Social Services Departments and the Needy Family Food
Program; and**

**WHEREAS, Dr. Eddie Brown did complete and presented the
consolidation structure to the eleven districts of the
Tohono O'odham Nation; and**

**WHEREAS, the Tohono O'odham Legislative Council had on various
occasions, the opportunity to inquire into the fitness of

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH. day of SEPTEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,628.0 FOR; 135.0 AGAINST; -0- NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
