**WHEREAS, the Tohono O'Odham Nation has recognized the importance of Head Start Education and stimulation; and**

**WHEREAS, the Tohono O'Odham Nation has operated a Head Start Program to provide and serve educational and pre-school learning experiences for children between the ages of 3 - 5 years of age; and**

**WHEREAS, the Department of Health and Human Services, Administration for Children, Youth and Families, has provided funding for the operation of the Head Start Program; and**

**WHEREAS, the Administration for Children, Youth and Families will provide funds for the continued operation of the Head Start Program to legal and qualifying applicants; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approves the Head Start Program Grant Proposal.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does authorize and request the Department of Health and Human Services to contract with the Tohono O'Odham Nation for the provision of services titled: Head Start Program.**

**Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract has been approved by the Department of Health and Human Services, Administration for Child, Youth and Families.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated Official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 16H. day of SEPTEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,612.0 FOR; -0- AGAINST; 151.0 NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
