WHEREAS, the Budget Committee recommended to the Chukut Kuk District Council that the attached budget and budget justification for FY 1995 in the amount of \$362,059.00 be approved; and

WHEREAS, the Chukut Kuk District Council approved the budget and budget justification for FY 1995 in the amount of \$362,059.00 and forwarded to the Legislative Council for approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves the Budget and Budget Justification for FY 1995 in the amount of \$362,059.00 for Chukut Kuk District.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 16TH. day of SEPTEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono


