

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 1995 Budget for the Tohono O'Odham
Legislative Branch and Appropriating Funds in the
amount of \$974,944.60)**

RESOLUTION NO. 94-408

WHEREAS, the 1994 fiscal year ends at midnight, September 30, 1994 and all spending authority granted under the 1994 budgets ends at that time; and

WHEREAS, the continued operation of the Legislative Branch of the Tohono O'Odham Nation requires adoption of an operating budget, the grant of spending authority and the appropriation of funds for FY 1995; and

WHEREAS, the Legislative Branch of the Nation has prepared and presented a budget that reflects the need of the Branch, said budget is attached hereto and incorporated by reference.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'Odham Nation that it approves the FY 1995 Budget submitted by the Legislative Branch. It is recognized that Payroll Taxes for Legislative Branch employees, in the amount of 10% of budgeted salaries are included in this budget. An additional amount equal to 16% of budgeted salaries is budgeted for Employee Benefits for Legislative Branch employees as part of the Executive Branch budget.


BE IT FURTHER RESOLVED that funds in the amount of \$974,944.60 are appropriated and authorized to be expended from sources of funding approved by this Council for support of the FY 1995 budgets of the Tohono O'Odham Nation.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 22ND day of SEPTEMBER, 1994 at a meeting at which a quorum was present with a vote of 820.5 FOR; 743.0 AGAINST; 199.5 NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
