**WHEREAS, Public Law 99-503, the Gila Bend Indian Reservation  
Lands Replacement Act of 1986 provides financial  
resources to the San Lucy District for the purposes of  
land replacement purchases, relocation, economic and  
community development; and**

**WHEREAS, Vi-Ikam Doag Industries (VDI) is a duly Chartered Non-  
Profit Corporation charged with the responsibility to  
promote and establish business, training and  
employment opportunities for District members; and**

**WHEREAS, the Vi-Ikam Doag Board of Directors presented a FY-95  
request to the San Lucy District Council for P.L. 99-503  
funds in the amount of \$249,845.00 to support  
governance, management, capital expenditures and  
developmental activities; and**

**WHEREAS, the San Lucy District Council reviewed the Board of  
Director's FY-95 request for P.L. 99-503 funds and  
approved said request in San Lucy District Council  
Resolution 09-071-94.**

**NOW, THEREFORE, BE IT RESOLVED that the Legislative Council  
hereby authorizes the appropriation of P.L. 99-503 funds**

**BE IT FURTHER RESOLVED that only the interest accruing from P.L.  
99-503 funds shall be used to support the 99-503 fund  
expenditures set forth in VDI's FY-95 request.**

**BE IT FURTHER RESOLVED that the VDI Board of Directors shall  
submit financial reports as requested by the Commerce  
Committee of the Tohono O'odham Legislative Council  
concerning the progress and status of the Corporation.**

**BE IT FURTHER RESOLVED that said funds shall be wire transferred  
from the Nation's Accounting Department to Vi-ikam  
Doag Inc. Bank One Account No. 2186-4764 at the Gila  
Bend, Arizona Branch in accordance with the following  
payment schedule:**




