**RESOLUTION NO. 94-412**

**WHEREAS, the Tohono O'odham Nation is presently operating the  
Judicial Branch with tribal funds; and**

**WHEREAS, any amendments affecting the funding level or change  
in the purpose for which the funds were budgeted are  
required to be submitted for review and approval by the  
Tohono O'odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and  
approval.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham  
Legislative Council that it does hereby approve the  
amendment to transfer funds between line items and  
authorizes additional funds of \$17,364.00 to be  
appropriated in accordance with the attached budget.**

**The foregoing Resolution was passed by the Tohono O'odham  
Legislative Council on the 22ND day of SEPTEMBER, 1994 at a  
meeting at which a quorum was present with a vote of 1,650.0 FOR;  
-0- AGAINST; -0- NOT VOTING; and 113.0 [08] ABSENT, pursuant to  
the powers vested in the Council by Section 1(d)(3) of Article VI of the  
Constitution of the Tohono O'odham Nation, adopted by the Tohono  
O'odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
