RESOLUTION NO. 94-415

**WHEREAS, the Office of the Advocate will experience a \$266,252.00
budget shortfall at the close of the FY-94; and**

**WHEREAS, the Tohono O'Odham Legislative Council has thoroughly
reviewed this matter; and**

**WHEREAS, the Chairman of the Nation has assured Council that this
will be a one-time appropriation; and**

**WHEREAS, the Tohono O'Odham Legislative Council finds that it is
in the best interest of the Nation to resolve this matter.**


**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council appropriates \$72,826.00 from the
General Revenue Fund and \$193,365.00 from Gaming
Revenues, for a total appropriation of \$266,252.00 to the
Office of the Advocate, FY-94 Budget, line item 060
Professional Services.**

**The foregoing Resolution was passed by the Tohono O'Odham
Legislative Council on the 29TH. day of SEPTEMBER, 1994 at a
meeting at which a quorum was present with a vote of 972.5 FOR;
790.5 AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the
powers vested in the Council by Section 1(d)(3) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


