

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for Representation
of Dorothy Pablo)**

RESOLUTION NO. 94-416

WHEREAS, pursuant to Resolution 94-077 the Legislative Council appropriated the sum of \$5,000., for use in providing legal services to Mrs. Dorothy Pablo in her efforts to have the body of her son, Christopher James Pablo, buried in the Tohono O'Odham Nation; and

WHEREAS, the law firm of Shimmel, Hill, Bishop & Gruender (the "Shimmel Firm") has been engaged to provide such representation; and

WHEREAS, the Advocate Program has presented the attached attorney contract with the Shimmel Firm regarding such representation; and

WHEREAS, the Domestic Affairs Committee recommends approval of the attorney contract.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Legislative Council approves the attorney contract with the Shimmel Firm, in the amount of \$5,000., and in the form attached hereto, for the period from March 8, 1994 through September 30, 1994.**
- 2. The Chairman of the Nation is authorized and directed to execute the attorney contract.**
