

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override Veto of Resolution No. 94-404 "Approving
FY 1995 Projected Revenues)**

RESOLUTION NO. 94-423

**WHEREAS, the Tohono O'Odham Legislative Council did by
Resolution No. 94-404 approve the FY 1995 Projected
Revenues ; and**

**WHEREAS, upon presentation of Resolution No. 94-404 to the
Chairman of the Tohono O'odham Nation, he did
disapprove thereof and returned it to the Council with
his objections in accordance with the provisions of
Article VII, Section 5 of the Constitution of the Tohono
O'odham Nation; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed
the Chairman's objections and after consideration,
again voted to pass Resolution No. 94-404 .**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
Legislative Council does hereby override the Chairman's
veto of Resolution No. 94-404 by a vote of two-thirds of the
votes cast.**

**The foregoing Resolution was presented to the Tohono O'Odham
Council on the 10TH. day of OCTOBER, 1994 at a meeting at which
a quorum was present and, by a vote of 1,763.0 FOR; -0- AGAINST;
-0- NOT VOTING; and 05 ABSENT, was passed by a majority of at
least TWO-THIRDS (2/3) 1,175.0 of the votes cast and became law as
provided in Section 5 of Article VII of the Constitution of the Tohono
O'Odham Nation.**
