- WHEREAS, the Tohono O'Odham Legislative Council has reviewed the Chairman's objections and after consideration, again voted to pass Resolution No. 94-404.
- NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham

 Legislative Council does hereby override the Chairman's

 veto of Resolution No. 94-404 by a vote of two-thirds of the

 votes cast.

The foregoing Resolution was presented to the Tohono O'Odham Council on the <u>10TH.</u> day of <u>OCTOBER</u>, <u>1994</u> at a meeting at which a quorum was present and, by a vote of <u>1,763.0</u> FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>05-</u> ABSENT, was passed by a majority of at least TWO-THIRDS (2/3) <u>1,175.0</u> of the votes cast and became law as provided in Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.
