applications for enrollment in accordance with Section 3 (c) of Article III of the Enrollment Ordinance; give notice of this Council's determination in accordance with Section 4 of Article III of the Enrollment Ordinance; and place the names of each applicant upon the membership roll of the Tohono O'Odham Nation in accordance with Article V of the Enrollment Ordinance.

The foregoing Resolution was passed by the Tohono O'Odham Council on the 10TH. day of OCTOBER, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1 of Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


