RESOLUTION NO. 94-427

**WHEREAS, the Tohono O'Odham Nation recognizes the need for
local health services in the San Lucy District; and**

**WHEREAS, the Tohono O'Odham Nation is concerned about the
potential disproportionate impact of Executive Order
12839 on health services provided to the members of the
San Lucy District; and**

**WHEREAS, the Tohono O'Odham Nation encourages, supports and
endorses the San Lucy District initiative to acquire
Indian Health Service funding to provide health services
in San Lucy District.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council authorizes the San Lucy District to
engage in any and all appropriate activities required to
secure funding from the Indian Health Services to
provide various health services to the members of the
San Lucy District.**

**The foregoing Resolution was passed by the Tohono O'Odham
Legislative Council on the 11TH. day of OCTOBER, 1994 at a meeting
at which a quorum was present with a vote of 1,507.5 FOR; -0-
AGAINST; 255.5 NOT VOTING; and 06 ABSENT, pursuant to the
powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono**


