**WHEREAS, the 1994 fiscal year funding levels for the Executive  
Branch had been extended until October 15 by the  
authority of the Legislative Branch through Resolution  
number 94-414; and**

**WHEREAS, the continued operation of the programs and  
departments of the Executive Branch of the Tohono  
O'Odham Nation requires adoption of an operating  
budget, the grant of spending authority, and the  
appropriation of funds for the 1995 fiscal year; and**

**WHEREAS, the Executive Branch of the Nation has prepared and  
presented a budget that reflects the needs of the Branch.  
This budget is attached hereto and incorporated by  
reference; and**

**WHEREAS, the Legislative Council of the Tohono O'Odham Nation  
has reviewed this budget and recommends its approval  
and adoption.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the  
Tohono O'Odham Nation that it approves the FY 95  
budget submitted by the Executive Branch. It is  
recognized that payroll taxes for the Executive Branch**

employees in the amount of 10% of budgeted salaries are included in this budget. An additional amount equal to 16% of budgeted salaries is budgeted for Employee Benefits for the employees of all three Branches of the Tohono O'Odham Nation and this is made part of the Executive Branch budget.

**BE IT FURTHER RESOLVED** that funds in the amount of \$10,387,365.00 are appropriated and authorized to be expended from the sources of funding approved by this Council for support of the FY 1995 budgets of the Tohono O'Odham Nation.

The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 13TH. day of OCTOBER, 1994 at a meeting at which a quorum was present, and by a vote of 178.0 FOR; 1,086.0 AGAINST; 288.0 NOT VOTING; AND 211.0 [07] ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'Odham Nation.
