RESOLUTION NO. 94-434

WHEREAS, a national Core Policy Team (CPT) has been established by the Director of Indian Health Services as the next step in a process that began with the IHS Quality Management Restructuring Work Group; and

WHEREAS, the Core Policy Team will be composed of representatives of Tribes, Indian organizations, and Indian Leaders, together with senior IHS officials and charged with the responsibility to design a new Indian Health Service for a new era in Indian health care; and

WHEREAS, the Tucson Office of Health Program Research and Development (OHPRD) has been asked to nominate a tribal representative to the team and has recommended the nomination of Frances Miguel.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby support the nomination of Frances Miguel for participation on the IHS Core Policy Team (CPT).


The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH. day of OCTOBER, 1994 at a meeting at which a quorum was present with a vote of 1,372.0 FOR; -0- AGAINST; -0- NOT VOTING; and 391.0 [09] ABSENT,


