

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 1995 Budget for the Tohono O'Odham
Executive Branch and Appropriating Funds in the
amount of \$10,256,987.00)**

RESOLUTION NO. 94-436

WHEREAS, the 1994 fiscal year funding levels for the Executive Branch had been extended until October 15 by the authority of the Legislative Branch through Resolution No. 94-414; and

WHEREAS, the continued operation of the programs and departments of the Executive Branch of the Tohono O'Odham Nation requires adoption of an operating budget, the grant of spending authority, and the appropriation of funds for the 1995 fiscal year; and

WHEREAS, the Executive Branch of the Nation has prepared and presented a budget that reflects the needs of the Branch. This budget is attached hereto and incorporated by reference; and

WHEREAS, the Legislative Council of the Tohono O'Odham Nation has reviewed these budgets and recommends its approval and adoption as presented.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'Odham Nation that it approves the FY 95 budget submitted by the Executive Branch. It is recognized that payroll taxes for the Executive Branch

employees in the amount of 10% of budgeted salaries are included in this budget. An additional amount equal to 16% of budgeted salaries is budgeted for Employee Benefits for the employees of all three Branches of the Tohono O'Odham Nation and this is made part of the Executive Branch budget.

BE IT FURTHER RESOLVED that funds in the amount of \$10,256,987.00 are appropriated and authorized to be expended from the sources of funding approved by this Council for support of the FY 1995 budgets of the Tohono O'Odham Nation.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH day of OCTOBER, 1994 at a meeting at which a quorum was present with a vote of 1,552.0 FOR; -0- AGAINST; -0- NOT VOTING; and 211.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
