**WHEREAS, by Resolution No. 94-417, the Tohono O'odham
Legislative Council approved an attorney contract with
the law firm of Shimmel, Hill, Bishop and Gruender to
provide legal representation for clients of the Office of
the Advocate; and**

WHEREAS, the attorney contract will expire on October 14, 1994; and

**WHEREAS, continued legal representation for clients of the Office of
Advocate is required until such time as full-time
attorneys can be hired to replace these contract
attorneys; and**

**WHEREAS, the Office of the Advocate has included \$30,000 in the FY-
95 Professional Services 060 line item for this contract.**

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby
approves an attorney contract with the law firm of
Shimmel, Hill, Bishop, and Gruender, for services to
be performed by Pete Delgado and Judy Dworkin, in
the amount of \$30,000., for a term commencing
October 17 and ending November 18, 1994 and in the
form attached hereto.**


