**WHEREAS, the Executive Office presented their FY'95 tribal budgets
for review and adoptions; and**

**WHEREAS, certain questions were raised in reference to the intent
of the Executive Office to administer OCM as an entity of
the Nation; and**

**WHEREAS, in order for existing projects to continue and the plan of
operation and financial analysis of the operations to be
presented to this Council; and**

**WHEREAS, the Chairman of the Nation and OCM did agree that 30
days would be sufficient time to gather the required data
to properly inform this Council.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
Legislative Council authorize O'odham Construction &
Materials to continue operations for 30 days for the
period October 14 through November 14, 1994 pending
the approval of the proposed FY'95 request.**

**BE IT FINALLY RESOLVED THAT the Chairman of the Nation and OCM
provide the requested information to properly inform
this Council.**




