

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating \$92,987 for Care and Maintenance of the Property
known as The Nation's Ranch)**

RESOLUTION NO. 94-439

**WHEREAS, the Tohono O'odham Nation owns property known as
The Ranch in Athens, Texas; and**

**WHEREAS, funds are required for the care and maintenance of this
property; and**

**WHEREAS, the Executive has presented a six-month budget
itemizing the cost of care and maintenance; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed
this budget and find that it is in the best interest of the
Nation to provide proper care and maintenance for the
property and structures.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
Legislative Council appropriates the sum of \$92,987 for
expenses expected during the next six months of Fiscal
Year 1995.**

**The foregoing Resolution was passed by the Tohono O'Odham
Legislative Council on the 14TH. day of OCTOBER, 1994 at a meeting
at which a quorum was present with a vote of 1,552.0 FOR; -0-
AGAINST; -0- NOT VOTING; and 211.0 [08] ABSENT, pursuant to the
powers vested in the Council by Section 1(d)(2) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
