

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorization to Continue Law Enforcement Services)**

**RESOLUTION NO. 94-440**

**WHEREAS, the Law Enforcement received a special appropriation in the amount of \$2,839,558 in December of 1993 from Tohono O'Odham National funding; and**

**WHEREAS, the Tohono O'Odham Nation's fiscal year ends on September 30, 1994 for FY-94; and**

**WHEREAS, it is the Tohono O'Odham Nation's desire not to interrupt the special appropriation funding for the Law Enforcement; and**

**WHEREAS, an accounting of all expenses from this special appropriation be presented before the Tohono O'Odham Legislative Council for fiscal year ending September 30, 1994.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby authorizes the Law Enforcement to continue operations at current spending levels in order that services will not be interrupted.**

**BE IT FURTHER RESOLVED that the expense report be made to Council in the 1994 November session.**

**BE IT FURTHER RESOLVED that this continuing Resolution shall expire November 18, 1994.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH day of OCTOBER, 1994 at a meeting at which a quorum was present with a vote of 1,552.0 FOR; -0- AGAINST; -0- NOT VOTING; and 211.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(D) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


