**WHEREAS, the Pisinemo District Council did meet on Wednesday,  
October 12, 1994 at a regularly scheduled meeting; and**

**WHEREAS, the District Council did approve the Pisinemo District  
budget for 1995 in the amount of Two Hundred Sixty  
Three Thousand, Four Hundred and Nineteen Dollars  
(\$263,419.00); and**

**WHEREAS, the Pisinemo District Council does feel the need to have  
an operating District office with staff and the people do  
benefit from those services available at the Pisinemo  
District office and services provided by the Pisinemo  
District staff; and**

**WHEREAS, the Pisinemo District Council did pass their FY-95 Budget  
in the amount of Two Hundred Sixty Three Thousand,  
Four Hundred and Nineteen Dollars (\$263,419.00); and**

**WHEREAS, the Pisinemo District Council also approved the  
distribution of \$60,000.00 for the following Communities:  
Pisinemo, Santa Cruz, San Simon, and Kupk/Dirtburn;  
each to be receiving an equal amount of \$15,000.00 each  
and to be placed under line items: 95-7-7101, 7102, 7103,  
and 7104 respectively; and**

**WHEREAS, each community of the Pisinemo District will submit**

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves the Pisinemo District's Budget in the amount of Two Hundred Sixty Three Thousand, Four Hundred Nineteen Dollars (\$263,419.00) submitted for approval and hereby acknowledge that a new Budget Justification will be forthcoming to include the equal distribution of \$15,000.00 to the aforementioned four District communities along with their budget justifications.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH day of OCTOBER, 1994 at a meeting at which a quorum was present with a vote of 931.0 FOR; -0- AGAINST; -0- NOT VOTING; and 832.0 [14] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
