BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes payment for NCAI Membership dues in the amount of \$1,000.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH. day of OCTOBER, 1994 at a meeting at which a quorum was present with a vote of 1,262.0 FOR; -0- AGAINST; -0- NOT VOTING; and 501.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
