3 **WHEREAS, by Resolution No 94-326, the Tohono O'odham Legislative**
4 **Council approved a consultant contract with Kim H.**
5 **Robinson for legislative and administrative advocacy**
6 **services to the Nation on issues affecting the Nation's**
7 **interests in the Pinacate and Gran Desierto del Altar**
8 **Biosphere Reserve in Sonora, Mexico and the Upper Gulf**
9 **of California (hereinafter referred to as the "Pinacates");**

13 **WHEREAS, the consultant contract expired on September 30, 1994;**

14 **and**

15 **WHEREAS, continued participation of the Nation in the**
16 **management of the Pinacates is required to protect the**
17 **Nation's interests; and**

19 **WHEREAS, the Cultural Preservation Committee recommends**
20 **approval of a consultant contract with Kim H. Robinson**
21 **for fiscal year 1995.**

23 **NOW, THEREFORE, BE IT RESOLVED THAT;**

- 24 **1. The Tohono O'odham Legislative Council hereby**
25 **approves a consultant contract with Kim H.**

4 **2. The Legislative Council appropriates the sum of**
5 **\$41,000, from the general revenue account, to pay**
6 **the fees and expenses under the consultant**
7 **contract.**

9 **3. The Chairman of the Nation, the Chairman of the**
10 **Legislative Council, and the Chairman of the**
11 **Cultural Preservation Committee are authorized**
12 **and directed to execute the consultant contract.**

15 **Legislative Council on the 14TH. day of OCTOBER, 1994 at a meeting**
16 **at which a quorum was present with a vote of 1,552.0 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and 211.0 [09] ABSENT, pursuant to the**
18 **powers vested in the Council by Section 1(f) of Article VI of the**
19 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
20 **O'Odham Nation on January 18, 1986; and approved by the Acting**
21 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
22 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
